

Annual Administrative Report for Inner Line Permit, Manipur (2025-26).

- 114 nos. of Mobile phones were procured through ILP GeM Portal and distributed to the offices of ILP Cell/Home Department, State/District ILP Monitoring Cells, All ILP Issuing authorities, All ILP Gates/Counters.
- 8 ILP Kiosks Machine have been installed at 3 ILP Gates (Mao, Airport and Jiribam) are procured and more Kiosks to be procured for other remaining ILP Cells/Booths.
- 53 Computer and printers sets for all DCs offices (ILP counters) and ILP gates/cells have been procured through GEM and distributed to all concerned.
- More Computers, printers, bar code scanners, equipment will be given to ILP gates, District Monitoring Cells, ILP issuing authorities.
- ILP Monitoring Groups have been monitoring daily checking activities and conducting ground Raids in suspicious places and people to detect with ILP type of invalid / fake /expired ILPs and act accordingly with the Manipur Inner Line Permit Guidelines, amended from time to time.
- Capacity building activities through training, seminars and IEC activities have been conducted.
- Conducted various Awareness and Training ILP Programmes through Virtually or physically at District as well as State level by Home Department.
- Training and Awareness Programmes (both virtually or physically) for ILP have been conducted to sensitise and highlight the recent developments in ILP and to clear doubts/queries, if any, to all DCs and SPs for every districts including important functionaries by State Home Department.

Type of Permits:

a. **Temporary:** valid for **30 days** not extendable but convertible to Labour or Special or Working subject to eligibility and approval. *Fee: Rs 100.*

b. **Regular:** valid for **90 days** not extendable but convertible to Labour or Special or Working subject to eligibility and approval. *Fee: Rs 500.*

c. **Labour:** valid for the **period of engagement or 1 yr** whichever is earlier; may be extended for twice. But second extension only with Government approval. *Fee: Rs 100 for fresh and Rs 300 for renewal. Cooling in period of for 6 months after second renewal.*

d. **Special Permit:** valid **for 3 years** extendable with Government approval. *Fee Rs. 5000 for fresh and Rs. 10000 for renewal.*

e. **Working Permit:**

(i) Half Yearly Working ILP : Valid for **180 days**, extendable upto 360 days in total subject to eligibility and approval.

(ii) Annual ILP : Valid for **360 days**, non-extendable subject to eligibility and approval
