Thursday, the 05th February, 2026

The House assembled at 04:00 p.m. of Thursday, the 05th February, 2026 in the Assembly Hall with the Hon'ble Speaker, Shri Th. Satyabrata Singh in the Chair.

MEMBERS PRESENT:

Hon'ble Chief Minister, 2 Hon'ble Deputy Chief Minister, 2 Hon'ble Cabinet Ministers, Hon'ble Chairman (Hill Areas Committee) and 45 Elected Members.

ADDRESS BY THE GOVERNOR:

Shri Ajay Kumar Bhalla, Governor of Manipur addressed the Seventh Session of the Twelfth Manipur Legislative Assembly.

Hon'ble Speaker, Shri Th. Satyabrata Singh adjourned the House at 05:12 p.m. for one hour.

The Session resumed at 06.10 p.m. with the Hon'ble Speaker Shri Th. Satyabrata Singh in the chair.

MOTION OF THANKS:

Shri K. Govindas Singh, Minister moved the Motion of Thanks to the Governor's Address and Shri Losii Dikho, Deputy Chief Minister seconded the Motion.

PRESENTATION OF COMMITTEE REPORT:

Shri Y. Khemchand Singh, Chief Minister presented the Ninth Report of the Business Advisory Committee, 2026 and also moved:

"That this House agrees to the allocation of time proposed by the Committee."

The House agreed and the Report was adopted.

STATEMENT BY THE CHIEF MINISTER:

Shri Y. Khemchand Singh, Chief Minister citing the inconveniences faced by some Hon'ble Members to attend the ongoing Assembly session due to the prevailing situation in the state, sought leave of the House to allow them to attend the ongoing session through virtual mode.

The House agreed.

(Smt. Nemcha Kipgen, Deputy Chief Minister; Shri L.M. Khaute, MLA; and Shri Ngursanglur Sanate, MLA attended the Session through virtual mode).

MOTION OF CONFIDENCE:

Shri Y. Khemchand Singh, Chief Minister moved the following motion:

“That this House expresses its confidence in the Council of Ministers.”

Shri O. Ibobi Singh, MLA participating in the discussion expressed happiness on the installation of a new popular government under a new Chief Minister and urged it to strictly maintain law and order for bringing peace in the state. He further appealed to all the communities residing in Manipur to commit themselves in safeguarding the territorial integrity of the state.

Shri K. Ranjit Singh, MLA participating in the discussion stated that the administration during the President’s Rule did not meet the expectation of the people and stressed the need for the new government to crack down on unlawful armed groups responsible for creating a divide between communities.

Shri K. Meghachandra Singh, MLA highlighted that the state is suffering due to the ongoing conflict and stated that a concrete roadmap should be prepared by the new government to resolve the issue of resettlement of IDPs.

Shri Th. Lokeshwar Singh, MLA participating in the discussion expressed confidence that the new government would work towards bringing peace and normalcy in the state. He also urged the new government for early resettlement of the IDPs to their original place of residence and for free movement in the National Highways.

Shri Surjakumar Okram Singh, MLA taking part in discussion urged the need to judiciously utilize all the armed personnel of both state and central forces in providing security for safe return of the IDPs.

Shri Y. Khemchand Singh, Chief Minister appreciated the Opposition Members for providing positive suggestions in bringing peace in the state and stated that it is the collective responsibility of all the MLAs to create a conducive atmosphere in paving the way for bringing peace and normalcy in Manipur.

The Motion of Confidence was carried through Voice Vote.

Hon’ble Speaker, Shri Th. Satyabrata Singh gave a valedictory speech and adjourned the House sine-die at 07:12 p.m.
