Monday, the 9th March, 2026

The House assembled at 11:00 a.m. of Monday, the 9th February, 2026 in the Assembly Hall with the Hon'ble Speaker, Shri Th. Satyabrata Singh in the Chair.

INTIMATION OF PRESIDENT’S ASSENT TO BILL:

The Secretary, Manipur Legislative Assembly intimated the House that the President had assented to “*The Manipur Scheduled Castes and Other Backward Classes (Regulation of Issuance and Verification of Caste Certificates) Bill, 2024*”.

PRESENTATION OF BUSINESS ADVISORY COMMITTEE REPORT:

Shri Y. Khemchand Singh, Chief Minister presented the Tenth Report of the Business Advisory Committee, 2026 and also moved:

“that this House agrees with the allocation of time proposed by the Committee”.

The House agreed and the Report was adopted.

PRESENTATION OF SUPPLEMENTARY DEMANDS FOR GRANTS:

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) presented the Supplementary Demands for Grants, 2025-26.

PRESENTATION OF BUDGET ESTIMATES:

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) presented the Budget Estimates, 2026-27 and made a brief statement.

DISCUSSION ON GOVERNOR'S ADDRESS:

Discussion on the Motion of Thanks moved by Shri Konthoujam Govindas Singh, Minister and seconded by Shri Losii Dikho, Deputy Chief Minister on Thursday, 5th February, 2026:

“that the Members of the Manipur Legislative Assembly assembled in this session are deeply grateful to the Governor for the Address which he has been pleased to deliver to this House on 5th February, 2026”.

Shri Konthoujam Govindas Singh, Minister initiating the discussion highlighted the government's comprehensive performance and significant achievements like constructing houses for IDPs and improving the law and order situation in the state, etc. He also highlighted the various developmental projects taken up in the state and the efforts being made to address unemployment issues. He also informed that the government is making efforts to let Manipuri Lai Haraoba recognized by UNESCO.

Shri Losii Dikho, Deputy Chief Minister, seconded the Motion of Thanks to the Governor's Address and highlighted the effort of the government in restoring peace in the state. He highlighted the progress being made to restore normalcy under the central leadership and appealed to all the Hon'ble Members to join the effort.

Shri Okram Ibohi Singh, MLA participating in the discussion, stated that the government need to give priority to restore normalcy in the state by improving the law and order situation. He appealed to the government to provide necessary compensation to internally displaced persons and address their grievances. He urged the government to determine the exact number of missing persons and those reported dead during the ethnic conflict. He also opined the need to take up initiative to include Manipuri Language in the list of Indian classical languages. He further appealed for conducting the election of local bodies which has been due for quite a long time.

Shri K. Meghachandra Singh, MLA participating in the discussion expressed that the Governor's Address lacked a concrete road map for the rehabilitation of the IDPs and peace-building initiative in the state. He also highlighted the government's inability to provide compensation to those affected by the flash floods that occurred three times during the previous year. Considering the significance of the state's art and culture, he suggested giving more priority to it.

Shri Y. Khemchand Singh, Chief Minister, replying to the discussion stated that the law and order situation in the state is improving with the government's effort in rebuilding the trust deficit between the conflicting communities and added that restoring peace and normalcy in the state is the collective responsibility of everyone in the state. He informed that the Union Cabinet is likely to sanction an amount of around Rs.430

crores for projects to be implemented under the PMGSY. He further informed that an expert committee is examining the matter regarding inclusion of Manipuri language as a recognised Classical Language of India.

The motion of Thanks to the Governor's Address was unanimously adopted by the House.

Hon'ble Speaker, Shri Th. Satyabrata Singh adjourned the House at 03:43 p.m. till 11.00 am of Tuesday, the 10th March, 2026.
