*The House assembled at 11:00 a.m. of Tuesday, the 10<sup>th</sup> February, 2026 in the Assembly Hall with the Hon'ble Speaker, Shri Th. Satyabrata Singh in the Chair.*

**LEAVE OF ABSENCE:**

Hon'ble Speaker, Manipur Legislative Assembly announced that S/Shri N. Biren Singh and Chinlunthang, MLAs had applied for leave of absence for the sitting from 10<sup>th</sup> March till 17<sup>th</sup> March, 2026. He further added that Shri Paolienlal Haokip had also applied for leave of absence for the sitting from 10<sup>th</sup> March till 13<sup>th</sup> March 2026.

**GENERAL DISCUSSION AND DISCUSSION AND VOTING ON SUPPLEMENTARY DEMANDS FOR GRANTS, 2025-26:**

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) moved the Supplementary Demands for Grants for consideration and passing.

*Demand Nos. 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 14, 17, 18, 19, 21, 22, 26, 29, 31, 34, 36, 38, 39, 40, 43, 44, 45, 47 and 48, were unanimously passed by the House.*

**GENERAL DISCUSSION ON BUDGET ESTIMATES, 2026-27:**

Shri K. Meghachandra Singh, MLA participating in the discussion on budget Estimates 2026-27 lamented that the present budget is much smaller than the previous year's budget and stated that this would adversely affect the state's developmental growth. He also urged to enhance the budget earmarked for rehabilitation of the IDPs. He further

queried on how the government would utilize the Rs.350 crores earmarked for economic empowerment of women and the mode of selecting the beneficiaries under the scheme. He asked the details of the developmental programs of road connectivity for which an estimate of Rs. 914 crores is earmarked and further queried on the plan taken up by the government for renovating/repairing roads not included in any other developmental programs. He expressed that as the state is facing huge fiscal liabilities the budget would not be able to ensure proper development in the state.

Shri Y. Khemchand Singh, Hon'ble Chief Minister replied that the present Budget Estimates seems smaller than the RE of the last year's budget since the Revised Estimates, 2025-26 had to cope with the earlier backlog and contingency charges. Budgetary provision for rehabilitation of IDPs were provided during the past years too and the present amount of Rs. 734 crores earmarked is only for the coming financial year. Regarding the budgetary provision earmarked in the budget for women's welfare, he clarified that an official notification would be published for availing the benefit. He further informed that the amount of Rs. 914 crores earmarked in the budget is only for those developmental works taken up under PMGSY and PWD and that many developmental works taken up under DONER and Ministry of Roads, Transport & Highways (MoRTH) are not reflected in the state's budget.

**INTRODUCTION OF MANIPUR APPROPRIATION BILL:**

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) move for leave to introduce:

*"The Manipur Appropriation (no.1) Bill, 2026"*.

The House granted the leave and the Bill was introduced.
