*Wednesday, the 11<sup>th</sup> March, 2026*

*The House assembled at 11:00 a.m. of Wednesday, the 11<sup>th</sup> February, 2026 in the Assembly Hall with the Hon'ble Speaker, Shri Th. Satyabrata Singh in the Chair.*

**MEMBERS PRESENT:**

Hon'ble Chief Minister, 2 Hon'ble Deputy Chief Minister, 2 Hon'ble Cabinet Ministers, Hon'ble Chairman (Hill Areas Committee) and 45 Elected Members.

**PAPERS TO BE LAID ON THE TABLE:**

Shri Y. Khemchand Singh, Chief Minister laid the following reports on the Table of the House:

- (i) Annual Report 2025-2026 of Manipur Lokayukta.
- (ii) Annual Report 2023-2024 of Manipur Information Commission.
- (iii) Economic Survey Manipur 2024-2025.

**LEAVE OF ABSENCE:**

Hon'ble Speaker, Manipur Legislative Assembly announced that Shri Kh. Raghumani Singh, MLAs had applied for leave of absence for the day's sitting.

*The House agreed and the leave was granted.*

**DISCUSSION AND VOTING ON DEMANDS FOR GRANTS, 2026-27:**

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) moved Demand Nos. 1, 2, 3, 4, 7, 8, 21, 23, 25, 32, 35, 37, 41 and 49 for consideration and passing.

Shri K. Meghachandra Singh, MLA moving cut motions on Police Department said conducting Census before the completion of resettlement and rehabilitation of the IDPs and identification of illegal immigrants would be inappropriate and stated the need for resolution of the House for deferring the exercise in view of the prevailing situation in the state. He said that free movement on National Highways should be restored and inquired on the measures taken up by the Government for restoration of free movement in the state. He lamented the lack of initiative by the Centre and State Government to effectively check the influx of illegal immigrants, transport of arms, ammunition and narcotics along the Indo-Myanmar border and urged for the completion of border fencing at the earliest. He also urged that the State Government should take the initiative to provide adequate compensation to the IDPs who have incurred huge loss due to the recent

crisis. He further stated that the looted arms and ammunitions from the state police armoury should be recovered in both the hills and valley and also urged the Government to announce the roadmap for bringing peace and normalcy in the state. Regarding PWD, he pointed out the various irregularities on the ongoing construction works in various parts of the state and urged for proper supervision of the construction of roads and bridges in all constituencies and also urged that the incomplete works be completed at the earliest. On Power, he expressed the need for timely completion of the recruitment process by the Department. On Youth Affairs and Sports, he expressed the need to take up the “One Village, One Playground” scheme as announced earlier at the earliest. He further expressed the need for bringing an infrastructural development and also inquired the measures to be taken up by the Department for bringing development in the field of sports. On Art and Culture, he said that the budget allocation of the Department is too meagre and opined the need to enhance it. He further lamented that the Department is understaffed and urged for filling up the vacant sanctioned posts in the Department.

Shri Konthoujam Govindas Singh, Minister (in-charge of Home & YAS) stated that the Government is working to formulate the Manipur Police Manual Code at the earliest as the state is at present following the Assam Police Manual Code. Regarding the Census exercise, he informed that the government is also considering approaching the central government to defer the census exercise in view of the prevailing situation in the state. He also informed that a committee has been formed to check the influx of illegal immigrants in order to identify and deport them if necessary and adequate security measures have been taken up for the same. He further informed that the Government is trying its best to fulfil the various needs of the IDPs. He informed that the number of arms recovered by security forces exceeds the number of arms looted but added that around 1000 number of arms looted from the state armoury are yet to be recovered. The department has been trying its best under the Unified Command for restoration of peace and normalcy in the state such as conducting strategic operations, formation of intelligence networks, setting up anti extortion cells, etc, he informed. Regarding YAS, he stated that the construction of the National Sports University is nearly complete and mentioned that the Department is planning to modernise the existing sports facilities in the state in order to compete with other states. He also informed that the Department would continue to pursue to implement the “One Village, One Playground” scheme as announced earlier. He also appealed for sincere participation of the guardian and school authorities for formation of under -17 football team for participating in the Subroto Cup but clarified that the present under-17 team could not participate in the last Subroto Cup 2025 due to some age related issues of the players.

Shri Y. Khemchand, Chief Minister while giving clarification informed that the Government is planning to carry out SIR and added that the house listing process would be conducted before the Census exercise. He stated that construction works along the

Imphal-Ukhrul-Jessami road (NH-202) could not be completed on time due to various factors and assured the House that the construction of the same would be completed at the earliest. On Power, he said some employees were recruited in 2014 by the Department and added that some more employees would be recruited through the MPSC. He further stated that the cancellation of 2019 recruitment for the post of group C and D due to various unforeseen circumstances was unfortunate but added that the same cannot be taken up as the matter was subjudice.

Shri Kh. Loken Singh, Minister clarified that the Department is planning to fill up vacant posts in the Art & Culture department in consultation with the Chief Minister. He further informed that the department has been providing assistance to artists under the CMAT scheme and any grievances of the artists would be looked into.

*Demand Nos. 1, 2, 3, 4, 7, 8, 21, 23, 25, 32, 35, 37, 41 and 49 were unanimously passed by the House.*

#### **CONSIDERATION AND PASSING OF THE MANIPUR APPROPRIATION BILL:**

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) moved:

*“that The Manipur Appropriation (no.1) Bill, 2026” be taken into consideration.*

And also moved that the Bill be passed.

*After clause by clause consideration the Manipur Appropriation (no.1) Bill, 2026 was unanimously passed by the House.*

#### **ELECTION OF THE THREE FINANCIAL COMMITTEES:**

Shri Y. Khemchand Singh, Chief Minister (in-charge of Finance) moved the following motion:

*“That in pursuance of Rule 233(1) of the rules of procedure and Conduct of Business in Manipur Legislative Assembly, this House do proceed to elect 7 (seven) Members each to the following Committees on March 16, 2026:*

- (i) Committee on Public Accounts.*
- (ii) Committee On Estimates.*
- (iii) Committee on Public Undertakings”.*

*The House adopted the motion.*
