Shri Y. Khemchand Singh, Chief Minister to move :

*“that a supplementary sum not exceeding Rs. 26,70,24,000/- be granted to defray the charges which will come in course of payment during the financial year ending 31<sup>st</sup> March, 2026 in respect of Demand No. 1 - State Legislature.”*

(ii) DEMAND NO. 3 - SECRETARIAT :

Shri Y. Khemchand Singh, Chief Minister to move :

*“that a supplementary sum not exceeding Rs. 2,55,36,000/- be granted to defray the charges which will come in course of payment during the financial year ending 31<sup>st</sup> March, 2026 in respect of Demand No. 3 - Secretariat.”*
